

## Emergency Preparedness in Senior Care Organizations

With emergency situations including fires, natural disasters, severe weather, influenza and viruses, as well as homeland security threats, senior care facilities need emergency preparedness plans and safety measures in place to keep their residents safe. In fact, long-term care facilities that participate in Medicare and Medicaid must develop and maintain comprehensive emergency preparedness plans to comply with requirements from the Centers for Medicare & Medicaid Services and the Occupational Safety and Health Administration.

A U.S. Department of Health and Human Services study found that an estimated 77 percent of skilled nursing facilities located in higher-risk areas for natural disasters have encountered challenges with planning emergency preparedness activities to keep their residents safe.<sup>1</sup> Ensuring proper staffing during emergencies and transporting residents during evacuations were pinpointed as the most frequently mentioned concern.<sup>2</sup>

Effective emergency preparedness plans to ensure these and other concerns are addressed should include myriad elements of risk assessment, staff training and emergency simulation exercises, provisions for evacuation and shelter-in-place, fire safety, and more. The following checklist is intended to help senior care facility leaders and staff assess and strengthen their emergency preparedness plans to optimize resident and staff safety.<sup>3</sup>
